During the 1st EDE-World Congress from 14. to 17.11.07 in Berlin the EDE will give the 1st EDE Award

Rules of participation

Only politicians who are or have been active in social politics can be proposed for the award. Projects, activities and initiatives promoted by these people in one of the EDEmember countries should be forward thinking, innovative, realised and topical in the field of old people's welfare (stationary, partly stationary, outpatient, different forms of living or other relevant projects of care for the elderly).

The presentation of the projects must contain the following points:

- Curriculum vitae of the proposed politician,
- Description of the project:
 - implementation schedule
 - costs and financing of the project
 - stages of the project
 - measurable results
 - presentation of the innovative character of the submitted project
 - political decision maker of the submitted initiative (incl. the corresponding legal requirements or initiative if applicable).

The projects can only be admitted if they are submitted by a federation whose country is a registered member of the EDE.

The award money is 25.000 Euro.

The award winner must be **personnally present** at the award ceremony. A replacement cannot be accepted.

The award winner agrees to invest the award money in the old people's welfare; he is expected to notify in advance where the money will go to.

Participation procedure

All EDE-members are invited to submit their proposal of a politician to the EDE-Secretariat in Cologne,

Closing date is August 20th 2007. The date of the postage stamp applies.

The description of the project must not exceed 6 DIN A4 pages (including spaces and paragraphs). type size 11, typeface Times Roman, preferably RTF-format or Word Windows 2000, line spacing 1. The documents must be submitted both **printed** and **digitally.**

The **application form** for the **EDE-AWARD** must be included with the project descriptions.

The application forms and enclosed documents become the EDE's property, where they will be kept carefully. On receipt of the application documents the EDE acquires the right to report, in the documentation of some of the projects, as regards content or extracts of these projects, in the media and other publications. Liability for the submitted documents is expressly excluded.

The applicant agrees to the aforementioned conditions without restriction. The judges' decision is final.

The documents can only be presented in **German**, **English** or **French**. Articles from countries who use a different language must be translated into one of these languages.

Award jury

An independent and highly qualified jury will choose the successful EDE-Award applicant.
